**(ONE WAY SYSTEM) ORDER 2024**

On the 27<sup>th</sup> day of November, 2024 Cyngor Gwynedd made the above Order in exercise of the powers conferred under Sections 1(1) and (2) 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers. The effect of the Order when it comes into force on the 9<sup>th</sup> December, 2024 will be to:-

(1) Prohibit any person from causing any vehicle to proceed along the road specified in the first column of the schedule hereto save in the direction specified in the second column of the schedule. Full details are contained in the Order which, together with the map showing the length of road concerned and a statement of the Council's reasons for making the Order are available. Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
