Ar y 3ydd o Orffennaf, 2024 gwnaed y Gorchymyn uchod gan Gyngor Gwynedd trwy ymarfer ei bwerau o dan y Ddeddf Rheoli Traffig y Ffyrdd 1984, fel y newidiwyd a phob pŵer galluogi arall ac ar ôl ymgynghori gyda Phrif Swyddog yr Heddlu yn unol â Rhan III o Atodlen 9 o Ddeddf Rheoli Trafnidiaeth Ffyrdd 1994.

Pan ddaw'r Gorchymyn i rym ar y 15fed o Orffennaf, 2024 ei effaith fydd gwahardd cerbydau rhag stopio unrhyw amser ar yr ochrau darn ffordd a bennir yn yr Atodlen isod.

Bydd eithriadau yn caniatáu stopio lle bo hynny'n angenrheidiol yng nghyswllt:-

- (a) rhai gweithfeydd adeiladu;
- (b) cynnal y ffordd;
- (c) cyflenwi nwy, trydan a dŵr neu waith statudol;
- (ch) cyflawni pwerau a swyddogaethau awdurdod lleol;
- (d) i bwrpasau'r post;
- (dd) i bwrpas yr heddlu, brigâd dân neu ambiwlans;
- (e) mewn unrhyw achos lle fo'r person sy'n rheoli'r cerbyd
 - (i) angen yn ôl y gyfraith i stopio;
 - (ii) yn orfodol iddo stopio i osgoi damwain, neu
 - (iii) ei fod yn cael ei atal rhag symud ymlaen oherwydd amgylchiadau sydd y tu hwnt i'w reolaeth

CYNGOR GWYNEDD
(24 HOUR CLEARWAY)
(LLANGOWER) ORDER 2024

On the 3rd July, 2024 Cyngor Gwynedd made the above Order in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1994. The effect of the Order when it comes into force on the 15th July, 2024 will be to prohibit vehicles from stopping at any time on the sides of lengths roads referred to in Schedule hereto.

Exceptions will permit stopping where necessary in connection with:-

- (a) certain building operations;
- (b) the maintenance of the road;
- (c) the supply of gas, electricity, water or other statutory undertakings;
- (d) the exercise of local authority powers and functions;
- (e) the exercise of postal functions;
- (f) fire brigade, ambulance and police purposes;
- (g) and to a vehicle stopping when the person in control of it:
 - (i) is required by law to stop;
 - (ii) is obliged to stop in order to avoid an accident; or
 - (iii) is prevented from proceeding by circumstances outside that person's control.

Full details are contained in the Order which, together with the maps showing the lengths of roads concerned and a statement of the Council's reasons for making the Order, may be examined at (a) Council Offices, Cae Penarlâg, Dolgellau, Gwynedd, LL40 2YB (b) Bala Public Library, Godre'r Berwyn Campus, Ffordd Ffrydan, Bala, Gwynedd LL23 7RU during normal business hours. Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
