Lockdown Business Fund

The fund consists of two separate grants, and has opened yesterday afternoon, 28 October 2020. The new scheme will include support for most businesses who receive a business rates (non-domestic rates) bill. No payments will be released automatically – an application must be presented to claim the funds. For information about the grants available, how to register, eligibility and how to apply, go to:

To save time, before you begin to complete the application please make sure you have carefully read the guidance and have the following information to hand:

- Your VAT Registration Number, Company Registration Number and HMRC Unique Taxpayer Reference (whichever of these is applicable to you)
- Your annual turnover pre-COVID (or forecasted turnover if the business is less than 12 months old)
- Your bank account details (bank name, account name, account number and sort code)

- Information about any public sector support you've received over the last three years (who provided the support, the value of the support and date the support was provided)
- Only if you're applying for the Non-Domestic Rates Grants: your Business Rates Reference Number (this is the code which appears on your Business Rates bill if you can't find your number, e-mail trethiannomestig@gwynedd.llyw.cymru. To prevent fraud we cannot provide this information over the telephone)
- Only if you're applying for the Discretionary Grant: a copy of the latest bank statement relating to the business (this could be a personal bank account if you don't have a separate account for the business) you'll receive an email after you submit your application asking you to upload the statement

A fixed budget has been provided for Gwynedd to fund the grant and the scheme will be administered on a first come, first served basis so it is important that an application is presented as soon as possible. Gwynedd Council has released a statement urging the county's businesses to register for Welsh Government financial support that is available to help companies affected by the current Coronavirus firebreak.
