## 1. Subject:

Implement the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11 so that children can be admitted to the nursery class in the September following their third birthday, and implement the change on 1 September 2019.

#### 2. Recommendation for the Decision:

To approve the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11 so that children can be admitted to the nursery class in the September following their third birthday, and implement the change on 1 September 2019.

## 3. The reason for the need for a decision:

After conducting an objection period on the above proposal, the Authority is required to determine whether or not it will proceed to implement the proposal.

### 4. Rationale and justification for reaching the decision

**4.1** Nearly all primary schools in Gwynedd admit children to nursery class in the September following their third birthday. At present, the age range of Ysgol Llanbedr is 4-11. The Governing Body of Ysgol Llanbedr submitted an application to Gwynedd Council's Education Department to amend the age range to 3-11 so that it can also admit children in the September following their third birthday. After giving consideration to the

application, the Education Department agreed to undertake a statutory process on the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11.

- **4.2** A decision notice was published on 3 August 2018, stating the decision of Gwynedd Council's Cabinet Member for Education to undertake a statutory consultation process on the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11 from September 2019 onwards.
- **4.3** In accordance with the Schools Organisation Code 006/2013, Gwynedd Council published a consultation document and held a statutory consultation with all relevant consultees between 17 September and 29 October 2018.

In addition to the consultation document, a background pack was published and this included the impact assessments of the proposal on the Welsh language, the community and equality. All documents can be seen at

- **4.4** After holding the consultation, in accordance with the requirements of the Schools Standards and Organisation Act (Wales) 2013 and Schools Organisation Code guidelines 006/2013, a report was created and uploaded onto the Council website on 30 November 2018 and the link (<a href="www.gwynedd.llyw.cymru/modernisingeducation">www.gwynedd.llyw.cymru/modernisingeducation</a>), along with hard copies, were shared with relevant beneficiaries. The report included the Council's response to all observations received during the consultation period.
- **4.5** After giving consideration to the consultation report, a decision notice was published on 8 January 2019, stating the decision of Gwynedd Council's Cabinet Member for Education to:
- Approve the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11 so that children can be admitted to a nursery class in the September following their third birthday, implementing the change on 1 September 2019.
- ii. Approve the publication of a statutory notice on the proposal in (i) above in accordance with the requirements of the Schools Standards and Organisation (Wales) Act 2013 and Schools Organisation Code guidelines 006/2013.

Undertake an objection process on the proposal to amend the age range of Ysgol Llanbedr from 4-11 to 3-11 from September 2019 onwards. This means that the school will be able to admit children to the nursery class in the September following their third birthday.

**4.6** In accordance with the Schools Organisation Code 006/2013, Gwynedd Council published a statutory notice and displayed it on the gate of Ysgol Llanbedr and hard copies were distributed to all staff, parents and members of the Governing Body of Ysgol Llanbedr.

A link to the statutory notice was placed on the Council's website (<a href="www.gwynedd.llyw.cymru/modernisingeducation">www.gwynedd.llyw.cymru/modernisingeducation</a>) for all other relevant consultees, in accordance with the Schools Organisation Code guidelines 006/2013.

The statutory notice was published on 16 January 2019 allowing 28 days for anyone to object to the proposal.

No objections were received to the proposal.

### 5. The next step

Subject to a decision to approve the proposal to change the age range of Ysgol Llanbedr from 4-11 to 3-11 so that children can be admitted to the nursery class in the September following their third birthday, and implement the change on 1 September 2019.

# 7. Any consultations undertaken prior to making the Decision: Chief Finance Officer

As the author has noted in part 4.1 of the report, almost every primary school in Gwynedd admits children to a nursery class in the September following their third birthday. Implementing this decision will not mean a 'net' financial implication for the Council, as the increase in the budget will be allocated to primary schools (the equivalent of the cost of those children attending the school) will be funded through a proportionate reduction in the budget which funds 'non-maintained nursery groups'.
