

GORCHYMYN CYNGOR GWYNEDD
(GWAHARDD A CHYFYNGU AROS A MANNAU PARCIO AR Y STRYD)
(ARDAL DWYFOR RHIF 9) 2025

Ar yr 22ain dydd o Ionawr, 2025 gwnaed y Gorchymyn uchod gan Gyngor Gwynedd trwy ymarfer ei bwerau o dan y Ddeddf Rheoli Traffig y Ffyrdd 1984, fel y newidiwyd a phob pŵer galluogi arall ac ar ôl ymgynghori gyda Phrif Swyddog yr Heddlu yn unol â Rhannau III a IV o Atodlen 9 o'r Ddeddf.

Pan ddaw'r Gorchymyn i rym ar y 3ydd o Chwefror, 2025 ei effaith fydd:-

1. Gwahardd i unrhyw gerbyd rhag aros ar unrhyw adeg a deiliaid trwydded parcio i drigolion neu gyfyngiad amser 90 munud dim dychwelyd o fewn 2 awr - 8 y.b. hyd at 4 y.p. ar hyd y darnau hynny o'r ffyrdd a bennir yn yr atodlen isod.

Bydd eithriadau yn caniatáu aros ar gyfer:-

- (a) codi a gollwng teithwyr;
 - (b) llwytho neu ddadlwytho nwyddau;
- a lle bo hynny'n angenrheidiol yng nghyswllt:-
- (c) rhai gweithfeydd adeiladu;
 - (ch) cynnal y ffordd;
 - (d) cyflenwi nwy, trydan a dŵr neu waith statudol;
 - (dd) cyflawni pwerau a swyddogaethau awdurdod lleol;
 - (e) i bwrpasau'r post;
 - (f) i bwrpas yr heddlu, brigâd dân neu ambiwlans;
 - (ff) ac o dan rhai amgylchiadau lle bo'r cerbyd yn gerbyd person methodig.

Mi fydd yna Drwydded Parcio i Drigolion a'r gost fydd:

£60 y flwyddyn am y car cyntaf a £90 y flwyddyn am ail gar.

Ymwelwyr: Mi fydd y trwyddedau yn cael eu gwerthu fesul 10 ar gost o £5.00. Bydd y drwydded, sy'n cael ei gosod ar ffenestr flaen y car gyda'r dyddiad a'r rhif plat wedi ei nodi, yn galluogi ymwelwyr i aros am hyd at 24 awr.

CYNGOR GWYNEDD
PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES
(DWYFOR AREA NO. 9) ORDER 2025

On the 22nd day of January, 2025 Cyngor Gwynedd made the above Order in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers then enabling and after consultation with the Chief Officer of Police in accordance with Parts III and IV of Schedule 9 of the Act.

The effect of the Order when it comes into force on the 3rd February, 2025 will be as follows:-

1. Prohibit vehicles from waiting at any time and resident parking permit holders or 90 minute time limit no return within 2 hours – 8 a.m. until 4 p.m. along those lengths of roads referred to in the Schedule hereto.

Exceptions will permit waiting for:-

- (a) picking up and setting down passengers;
 - (b) loading or unloading goods;
- and where necessary in connection with:-
- (d) certain building operations;
 - (e) the maintenance of the road;
 - (f) the supply of gas, electricity, water or other statutory undertakings;
 - (g) the exercise of local authority powers and functions;
 - (h) the exercise of postal functions;
 - (i) fire brigade, ambulance and police purposes;
 - (j) and in certain circumstances when the vehicle is a disabled person's vehicle.

There will be a Resident Parking Permit and the cost will be:-
£60 per year for the first car and £90 a year for a second car.

Visitors: The permits will be sold in units of 10 at a cost of £5.00. The permit, which should be placed on the front window of the car with the date and number plate noted, will enable visitors to stay for up to 24 hours.

The Order, together with maps showing the length of roads concerned, together with a Statement of Reasons for making the Order may be examined during normal working hours at the:-

- (a) Council Offices, Caernarfon and Pwllheli
- (b) Post Offices Beddgelert, Caernarfon and Porthmadog
- (c) Public Libraries, Caernarfon and Porthmadog.

Full details are contained in the Order which, together with the maps showing the lengths of roads concerned and a statement of the Council's reasons for making the Order are available. Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
